Terms and Conditions for the Sicily Yoga Retreat (19-24 September 2025)

These terms and conditions apply to the yoga retreat organised by **Radha's Yoga Project**. By booking this retreat, you agree to the following:

1. Booking and Payment

- A non-refundable deposit of £500 is required to secure your place. The remaining balance must be paid by 31/07/25.
- Your booking is confirmed only upon receipt of your deposit. Failure to pay the balance by the deadline may result in the loss of your place.

2. Room Allocation

- Rooms are allocated based on:
 - 1. Suitability for twin occupancy or specific mobility requirements.
 - 2. Date of deposit payment (first-come, first-served).
- All rooms are priced equally, despite differences in size, layout, or views.

3. Dietary & Special Requirements

• If you have any dietary restrictions, allergies, or special requirements, it is your responsibility to notify **Radha's Yoga Project** in advance. While we will do our best to accommodate your needs, we cannot guarantee that all dietary preferences will be met.

4. Cancellation Policy

- If you cancel:
 - o Deposit payments are non-refundable.
